#### **CLIENT REGISTRATION PROCES**



Register at <a href="www.cityfit.pl">www.cityfit.pl</a> by submitting your details and selecting a membership type. Next, print out the legal guardians' declaration form, which provides consent for the conclusion of a membership agreement and for your use of the CityFit services.



The form is also available at <a href="www.cityfit.pl">www.cityfit.pl</a>, from the club's lobby and from your account section. Wait for an e-mail with your account password, which you should receive during the registration process. You will also receive a text message and an e-mail with a PIN code needed to register your fingerprint map during the first visit at the club.



**3.** Give the declaration form to your legal guardians so they can sign it.



Return the signed form after entering the personal details of the person who will be joining the club – such data are required to create an account with CityFit. Pass the form to the staff at your club or put it in the document box near the club's entrance.



Wait for an SMS confirming activation of your CityFit account. Account activation makes it possible to process payment for the selected membership type.



**6.** Log into your account to pay for the membership.



Pay for the membership using a payment method of your choice: payment card or standing order. Remember that a standing order can only be set for your own bank account.



**8.** Come for your first visit and scan your fingerprint map.
