I am / we are aware and that the CityFit Club is a self-service club available for customers 24/7 and that exercises done there may prove dangerous, and I/we assume the responsibility for any accidents and injuries resulting from my/our minor child's failure to observe the safety rules and the terms and conditions applicable at the Club CityFit. I/we declare that my/our minor child is physically fit and there are no contraindications for him/her to work out. Being aware of the possible injury while working out at the CityFit Club, I/we acknowledge that I/we should buy accident insurance for my/our minor child.

Furthermore, I/we, the undersigned, authorise my/our minor child to enter into a remote contract with CityFit to use the services offered by the CityFit Club. I/we declare that I/we assume the liability for any damage arising in particular due to improper performance or non-performance of the contract and I will pay any amounts due under the contract entered into by my/our minor child.

In addition, we have read the information, including the scope of personal data our son/daughter made available to you for processing (forename/surname/email/phone number/PESEL/address of residence) and the purposes for their processing, and in the scope of data processed on the basis of our son/daughter's consent, we confirm that such consent has been granted.

**The legal basis for the processing of personal data by the Controller includes:** a legal obligation incumbent upon the controller (the requirement to obtain parental consent in connection with the provision of services to a child) and the legitimate interests of the Controller (in relation to the potential pursuit of claims arising from the concluded agreement between us and the child). The Controller may transfer personal data to companies in the Controller's group (they perform specific roles on behalf of the Controller, helping the Controller to provide services or manage IT systems for supporting the clubs. These entities process only the data which are necessary for the performance of their roles and in accordance with contracts entered into), entities outside the Controller's group with which the Controller has business contracts and which render services to the Controller, e.g. providers of services related to the processing of payments with credit cards and legal services.

**You have the right to:** • Request from the Controller access to their personal data or obtain a copy of the data (provided that this right may not adversely affect the rights and freedoms of others, including trade secrets or intellectual property) and the right to rectify them when they are inaccurate, as well as in cases provided for by law, the right to erase or restrict the processing of data, • Object to the processing of data in certain situations. The objection will be examined by the Controller.
